The 1st issue was about a public hearing being waived on a subdivision on Bartlett Drive. The 2nd issue was about a lot line change because a house was built in the right of way on Bartlett Drive.

Mr. Coolidge told the Board that an application (07-10) submitted on 3/1/2010 by Rosemary Bartlett (for parcel #34.06-1-2.1) for a minor subdivision on Bartlett Drive only paid \$100.00 and received (2) lots subdivided. \$200.00 should have been received. Mr. Coolidge stated that Robert Busler, from LaFave, White and McGivern, told him that on the day of the meeting it was changed from (1) lot to (2) lots and it was an oversight it wasn't paid.
