Discussion:

Update of Highway Dept.: The following email was sent to the Board members before the meeting.

- So far the first part of winter has been relatively normal, we have had some mechanical breakdowns on some of the trucks.
- We have had to weld some frames on our spare plow (1999`) which we are currently using until our replacement truck arrives. Hopefully by the end of the month. Also, our 2005 truck needed some work done on the rear end. We also did this in house and avoided sending it out to a frame shop.
- The salt/sand barn is working exactly the way we expected it to. There has been a lot less mixing and breaking of large frozen chunks of sand. I love the arial photo taken by Matt Cooper of B and L.
- As we look forward to March and I hope to continue to keep Covid out of the barn and Transfer site. As far as a vaccination availability the Superintendents assoc. is trying to get us on the list, but I personally don't believe we will.

Update Park & Rec:

- Supervisor Marcinkowski told the Board that people were wondering why the skating rink is not open. Mr. Marcinkowski stated because of the uptick in the covid virus it remains closed. The Board agreed.

The Board reviewed a spreadsheet of expenses and revenues for the past (9) years for the Town Justices. The salaries have essentially doubled with the revenues going down. The Board all agreed that (1) Judge can handle the workload. Both Judges are up for election this year so this would be the time to go to a single Judge. The Board wants to follow all the guidelines to make it happen. The Town Board will have to do a permissive referendum next meeting.

Mr. Parmes thanked the Board for the use of the ice rink to store 200 cases of food, for the February 13th TFP Food Bank of Central NY free food distribution.
