Discussion:

Attorney James Burrow, Conboy, McCay, Bachman & Kendall, LLP, could not make the meeting tonight. The Board would like him to come to the next meeting.

Joel Zimmer told the Board that his family has spent \$1,000.00 fighting the violation of a trailer on Lake of the Woods. He told the Board that the trailer has been there since 1974 and that nobody resides in the trailer. He questioned why it was not grandfathered in. Supervisor Marcinkowski told him that a complaint was made to the Zoning Officer and Mr. McKeever is required to enforce the law. The Supervisor stated that it had gone to court and a decision has been made by the Judge. Also, he would get some more answers for him after he researched it.

Supervisor Marcinkowski told the Board that Amy Funk is willing to become Theresa's Dog Control Officer. She has agreed to \$4,000.00 for the rest of the year. She will be paid on a monthly basis and will need to submit a report to receive pay. She has agreed to go after delinquent licenses and in the future work on an enumeration for the Town.

Discussion:

The Theresa Food Pantry is asking for volunteers to help on Saturday mornings. They are also seeking someone to take over running the food pantry. Councilmember Rajner told the Board that the Village would put it in the next newsletter.

Supervisor Marcinkowski told the Board that he went to the last Progress Group meeting and was asked how much the Town was contributing to the Easter Egg Hunt. The Recreation Director did not offer any money for the event, only use of the rink. Mr. Parmes said it was understood that only the use of the rink was offered.

Mr. Parmes told the Board that the Progress Group is trying to get a website up and running. The Group would like a link on our website to theirs.

The Santway Park survey (see attached) results were read by the Board members. A questionnaire was sent out in the Village light bill. There will be a meeting at the fire hall on March 27th to discuss everything. They would like as much interest as possible to get a grant.

Mike Goodnough told the Board he had been reading rants and raves and wanted to come to the meeting and see what it was all about. He stated that Supervisor Marcinkowski was the best Supervisor there has ever been and he has known all of them in his 68 years as a Theresa resident. Also, Superintendent Edgar is the best Highway Superintendent ever. He stated that the whole Board does a darn good job. Mr. Marcinkowski said that there are disgruntled people and he invited them to attend meetings on rants and raves. He also appreciates Mr. Goodnough coming to the meeting and telling his opinion.

The Board discussed switching to selling bags, instead of stickers, for garbage at the transfer site. They will look into the price of bags. The Town Clerk with the help of the transfer site employees will collect addresses from everyone using the site for a couple of months this summer. The Town Clerk will then cross reference to the tax roll. Mr. Edgar brought to the Board's attention that Jefferson County charges \$50.00 per dump truck tire now. Also, they have to be cut in half and he has no easy way to do it.

A letter from NYS DOT to Senator Ritchie was read about reducing the speed limit on Route 37. Based on their review it is not recommended.

The Town Board approved the use of facilities application for a Joel Davis Youth Baseball Tournament to be held August 11th & 12th. The Board agreed that drainage is needed on McNickle Field this summer but would wait until after this tournament (August 13th) to close the field.
